Quotations are hereby invited for the **SUPPLY, DELIVERY, POSITIONING & DAILY SERVICING OF HIRED NON-FLUSH PORTABLE CHEMICAL TOILETS THROUGHOUT NDLAMBE AREA.**

Specifications:

- Supply, deliver, daily service and collection thereafter of 60 x HIRED NON-FLUSH PORTABLE CHEMICAL TOILETS throughout area of Ndlambe in designated areas (to be discussed with Mr Madlebe, Senior EHP)
- This will be for the period **15 December 2017 up until 07 January 2018.**

Prospective Bidders Shall Take Note of the Following Bid Conditions:

- The bid price be in the form of a daily rate which Ndlambe municipality will be charged in respect of the required services.
- Prices must be valid for at least ninety (90) days from the closing date.
- Prices quoted must be firm and must be inclusive of VAT.
- Ndlambe Municipality does not bind itself to accept the lowest bid or any other bid and reserves the right to accept the whole or part of the bid.
- Proof of Company registration must be provided.
- An original tax clearance certificate issued by SARS must accompany all quotations OR a tax reference number and PIN or TCC number must be provided.
- Evidence of registration of company on the Central Supplier Database must be provided (CSD "MAAA" number).
- Bidders must complete Council's Declaration of Interest form (**MBD4**).
- Bidders must complete Certificate of Independent Bid Determination (**MBD9**).
- Bidders who wish to claim for preferential points in terms of the Preferential Procurement Regulations, 2017, must submit a completed form **MBD 6.1** as well as a **CERTIFIED COPY** of the proof of B-BBEE status level of contribution.
- Municipal Billing Clearance Certificates (bidding entity & directors/members' residence) are to be provided.
- It should be noted that the 80/20 points system will be applied, 80 being for price and 20 for the B-BBEE status level as defined in the Preferential Procurement Regulations, 2017.
- Failure to comply with above conditions will result in disqualification of the bid.
- The award will be made in terms of the Municipality's Supply Chain Management Policy.
